What is the purpose of this statement?

This document tells you how the Russell LifePoints® Target Date 2045 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Superannuation Management Nominees Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of the fund

The Russell LifePoints® Target Date 2045 Fund aims to produce returns that provide capital growth and income consistent with its current asset allocation. The allocation to income assets increases progressively until it reaches 80% in 2045.

What are the risks of investing?

Risk indicator for the Russell LifePoints® Target Date 2045 Fund:


How has the fund performed?

This shows the return after fund charges and tax for each complete year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 March 2018.

^{*} Annual membership fee calculation involves calculating the total of member fees payable across all those participating employers where the member pays for the fees, and dividing by the total number of members from all participating employers, and multiplying by 12 to convert to an annual average.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jacob had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jacob received a return after fund fees and tax were deducted of \$945 (that's 9.45% of his initial \$10,000). Jacob also paid \$25.85 in membership fees. This gives Jacob a total return of \$919.15 for the year.
